2007 Town Meetings and Training Conferences

Dear Chief Executive Officer:

I'm happy to announce the schedule for this year's Town Meetings. I encourage you to attend one of the four sessions scheduled for the second half of this year. We hold the Town Meetings to provide an informal forum for thrift executives and regional senior managers to discuss current issues facing the thrift industry. We plan to share our views on recent regulatory and examination issues, and will seek your input on challenges you see in your business and markets.

We appreciate the opportunity to hear from you about the risks and issues you may be seeing in your local economies, in the various real estate markets in which you lend, and in any new lending or financial products and services that you may be seeing in your markets. Please consider bringing your Chief Lending Officer or Chief Financial Officer to participate in the discussion. We are asking for a limit of two executives per institution to facilitate an active dialogue with all attendees.

Enclosed you'll find a registration form for the Town Meetings with the tentative dates and cities where the Town Meetings will be held, as well as specific meeting locations and times. We are also planning a separate series of CRA/Compliance workshops and Financial Manager meetings. We hope these additional training opportunities will help support your management team in keeping current on critical issues in these areas. The CRA/Compliance workshops will cover OTS's new CRA rule, fair lending, flood insurance and other compliance hot topics. These sessions will be held on July 10th in Denver, CO; July 17th in Seattle, WA; July 19th in Santa Ana, CA; and July 23rd in Daly City, CA. The Financial Manager program will cover topics relating to accounting, financial reporting, regulatory capital and capital markets. These sessions will be held on September 11th in Denver, CO; September 13th in Los Angeles, CA; and September 17th in Seattle, WA. We will send a separate Regional Bulletin in the coming weeks with more information and registration instructions for the CRA/Compliance workshops and Financial Manager training sessions.
