Dear Chief Executive Officer:

Planning for the West Region's 2008 regulatory outreach and training events is well underway. I'm pleased to inform you that we will be adding two new forums to our regular palette of sessions this year:

- First, we will be hosting a series of four one-day forums throughout the region designed for Chief Credit Officers/Chief Lending Officers. The current economic environment, with increasing delinquencies, escalating levels of nonperforming assets, declining housing values, and other emerging credit quality problems, poses serious challenges for the management of thrift institutions. In our workshops, we will share and discuss what we are seeing in the marketplace; highlight current regulatory and examination issues as well as our expectations; provide you with an opportunity to raise any regulatory questions that you may have; and discuss other lending and credit quality issues of mutual interest.
- Second, we will be hosting a one-day Directors Forum to provide training to members of your Board of Directors on a number of topics, including Board of Director fiduciary responsibilities, current regulatory and consumer compliance issues, OTS's supervision and exam processes, corporate governance issues, and other matters requiring the attention of directors.

Based on your positive feedback, we will again host CRA/Compliance Officer Workshops, Thrift Financial Manager (CFO) Seminars, and our Town Hall Meetings with CEOs. The specific agendas and logistics for all of these events will be sent to you as the year unfolds.
